I have received feedback from a couple employees that there are some "dead" spots in the shop and yard regarding our WIFI.

Every worker uses wifi enabled devices and we need to make sure we have a strong wifi signal throughout the shop and yard.

Sounds like we need to schedule some time for your team to come out, identify the weaknesses in our network and add extenders as needed to boost our wifi signal.

I talked to Sam and he suggested that we stick with Ubiquiti extenders (assuming they make them), to make our wifi access point management system consistent.
